A VIDEO RECORDING OF AN EVENT WILL ONLY BE AUTHORISED SUBJECT TO THE FOLLOWING RESTRICTIONS:

- Recordings may only be supplied to the individuals of whom the video recordings is made for their **private domestic viewing only**.
- NO public screening (ie. not in a domestic premise) and NO broadcast** are allowed.
- The recording of any staged event (such as a play, ballet or opera) where the performance right in the musical works was granted by the Music Publisher either directly or through an agency agreement with the Australasian Performing Right Association (APRA) is not authorised under this Licence. Permission for such recording must be obtained directly from the Music Publisher (or their agent) from whom the performance licence was obtained.
- The video recordings **must NOT contain any promotional or advertising material** or any other matter specifically designed to encourage the purchase, use or support of particular goods or services.
- The Special Event video recordings Licence is limited to the use of AMCOS controlled musical works. This licence does not authorise the reproduction of AMCOS controlled Production Music Recordings. If you wish to use Production Music Recordings, you will need to secure an AMCOS Production Music Agreement and pay the rates detailed under the Production Music Rate Card issued by AMCOS.
